4. If the applicant is 18 years old or above, the application form should be enclosed with a photocopy of the applicant's Macao SAR Resident Identity Card.
5. If the applicant is an underage, the application form should be enclosed with photocopies of the identification document of the applicant and one of the parents or the legal representative.
6. The front side and the back side of the Macao SAR Resident Identity Card should be photocopied on the same page of a plain white A4 sized paper.
