Remarks :

1. The submission deadline of this application is on 31st December, 3 years after the year of the cheque.
2. This Cheque Collection Authorization Form is only applicable to persons whose cheque is returned to the Identification Services Bureau or persons who have requested to collect the re-issued cheque at the Identification Services Bureau.
3. If the applicant is an underage, interdicted or to-be interdicted person, one of the parents or the legal representative should sign on behalf of the applicant.
4. If the applicant is 18 years old or above, the authorization form should be enclosed with a photocopy of the applicant's Macao SAR Resident Identity Card.
5. If the applicant is an underage, the authorization form should be enclosed with photocopies of the identification document of the applicant and one of the parents or the legal representative.
6. The authorized person must be 18 years old or above, the authorization form should be enclosed with the photocopy of the identification document of the authorized person.
7. The front side and the back side of the Macao SAR Resident Identity Card should be photocopied on the same page of a plain white A4 sized paper.
8. This authorization form should be submitted to one of the following addresses by post or by an authorized person in Macao:

9. The authorized person should present the original copy of his/her identification document for identity verification when collecting the cheque.
