Remarks :

- The submission deadline of this application is on 31st December, 3 years after the year of the cheque.
- This Cheque Collection Authorization Form is only applicable to persons whose cheque is returned to the Identification Services Bureau or persons who have requested to collect the re-issued cheque at the Identification Services Bureau.
- If the applicant is an underage, interdicted or to-be interdicted person, one of the parents or the legal representative should sign on behalf of the applicant.
- If the applicant is 18 years old or above, the authorization form should be enclosed with a photocopy of the applicant's Macao SAR Resident Identity Card.
- If the applicant is an underage, the authorization form should be enclosed with photocopies of the identification document of the applicant and one of the parents or the legal representative.
- The authorized person must be 18 years old or above, the authorization form should be enclosed with the photocopy of the identification document of the authorized person.
- The front side and the back side of the Macao SAR Resident Identity Card should be photocopied on the same page of a plain white A4 sized paper.
- This authorization form should be submitted to one of the following addresses by post or by an authorized person in Macao:

 - Macao Government Services Centre in Islands Address: Rua de Coimbra, No. 225, 3/F, Taipa
 - Islands District Public Services Centre (Seac Pai Van Station) Address: Avenida de Vale das Borboletas, Complexo Comunitário de Seac Pai Van, 6/F, Coloane
- The authorized person should present the original copy of his/her identification document for identity verification when collecting the cheque.
